

### 1. Formalities

### 1.1 Notices of Motion

### NOM 1: Stated Supply at Rustenburg

At a time convenient to the council or when the Ministry Committee report is received: That Advocate Rean Fourie be appointed as Stated Supply to the Rustenburg Presbyterian Church. The absence of congregants in worship services due to their participation in these Association Activities become even more visible and crippling to Sunday worship services in smaller congregations, thus in my view counter productive. At a time convenient I will move that Presbytery notes that Emmanuel and Grace are in a process to appoint Craig Smith as an "Executive Pastor." I will also ask that Presbytery offers some advice as this is a pastoral/administrative role.

# 2. Office Bearer's Reports ()

# 2.1 Outgoing Moderator's (Glynis Goyns)

Greetings in the precious name of Jesus.

Thank you for giving me the privilege of serving you as Moderator. The past two years have been hugely challenging and rewarding, as well as exhausting at times. It seems an opportune moment as Patrick Nyauza prepares to "take up the reins" as the incoming Moderator to celebrate some of the highlights of the past two years and to consider a few of the low points and their significance.

### **Highlights to Celebrate**

- 1. PEDAL PROJECT: Despite the huge amount of effort entailed in this project, it was enormously worthwhile not only from a financial point of view, but also in terms of:
  - 1. building a sense of community between our congregations, especially the outlying ones, by means of
    - 1. the visits made to congregations throughout the Presbytery during and after the actual marathon
    - 2. the booklet telling the story of each congregation which was circulated on the anniversary of the Project in May 2008
  - 2. celebrating our diversity as we discovered and explored the differences in each congregation and local community
  - 3. humbling us as Theo and I experienced the mighty hand of God at work in every

- congregation, urban and rural, no matter how large or small, rich or poor
- 4. providing the opportunity to address the long-term vacancies in the congregation within our Presbytery in a meaningful way.

Many thanks are due to Theo for this creative idea and for the "sweat equity" that he and many members of his family and Emmanuel congregation invested in the project. Thanks must also go to the many donors who dug deep into their pockets to support the Project and raise considerable sums of money, as well as to congregations and individuals who graciously extended hospitality to Theo and I during the month of May 2007.

What an amazing experience to receive the open welcome, love and care of so many people from so many different backgrounds!

2. LICENSING, ORDINATIONS, INDUCTIONS, & APPOINTMENTS: We licensed four probationers in February 2007, namely Wonke Buqa to serve at Saints, Highveld and CPC, Lentekile Mashoko to serve at Mamelodi Gardens and Emmanuel, Sisanda Mpafi to serve at St Peters, Mothutlung, and Gerald Posthumus to serve at St Marks and Cullinan. Between February and March 2008, these probationers were all ordained and appointed/called to the congregations they served the previous year, except for Wonke who was appointed to Mamelodi East, while Feb 2008 saw the licensing of yet another probationer, Vuyo Mbaru, to Khayakhulu. At St Paul's, Mariti, we celebrate CDE Emmanuel Jack's completion of the sacrament's test and anticipated licensing to serve the sacraments.

In addition, four ministers were called and inducted, namely:

- 1. Chris Moore to Highveld Community Church on 25/01/07
- 2. Andries Combrink to Centurion West Presbyterian Church on 04/10/07
- 3. Gary Sinclair to St Columba's on 06/03/08
- 4. Llewellyn Scott to St John's on 17/04/08.
- 3. MISSION & OUTREACH: We celebrate in the steady growth of Grace Presbyterian Church in Moreleta Park since its seeding by Emmanuel in January 2007 and in the planting of two more nuclear congregations in 2008, namely Orchards by Jonas Lediga and Lynnwooddrif by Trinity and Highveld, as well as the thriving partnerships existing between these churches, together with those existing between Highveld and Ruighoek, Emmanuel and Mamelodi Gardens, Cullinan and St Marks, and now Cullinan and CPC.
  - We rejoice in the missionary work being done by André van Blydenstein with OMS and Justus Potgieter with FEBA Radio, as well as the new incentive for missionary support in our Presbytery following meetings initiated by Dennis van der Spuy and his Committee.
- 4. SANCTUARIES: St James, Matsulu, and Centurion West celebrated the consecration of their new church buildings in May and July 2007 respectively, while St Andrews, Pretoria, and Cullinan respectively celebrated the centenaries of their sanctuaries in 2007 and 2008. St Andrew's hosted a series of events from June through to December 2007, including a flower festival, tea garden, organ recital, film festival, dinner, Christmas carol service, and service of praise and thanksgiving. Cullinan held a special centenary service on Sunday afternoon 05/10/08, filling their sanctuary to capacity.

This totals five probationers licensed, four ministers ordained, four ministers inducted, the filling/partial filling of eight previously vacant congregations, the consecration of two new sanctuaries, the seeding of three new congregations over the past two years, and

establishment and/or strengthening of six partnerships between congregations within the Presbytery since January 2007. What an incredible blessing for which we give praise and thanks to our Father, the Giver of all good gifts!

On a slightly more "mundane" level, further events worth noting were:

- 1. A meeting at the end of July 2007 with the Moderators and Clerks of Highveld and Egoli Presbyteries to discuss the possibility of establishing a synod. It was decided not to pursue this at present, but to co-operate on a less formal basis by sharing resources and meeting together from time-to-time.
- 2. A joint consistory meeting in October 2007 with Highveld and Egoli to workshop the new UPCSA Statement of Faith with Rev Doug Bax.
- 3. Sharing of human resources between Highveld and ourselves to resolve problems within Highveld Presbytery.
- 4. The upgrading of the mission house at Khayakhulu, especially with respect to the installation of ablution facilities.
- 5. Dedication in October 2007 of the Vision, Mission, and Medium-term Strategic Plan at Thumedi Makgahlela to prepare for the filling of their vacancy.
- 6. Participation in the Eston Minister's Conference in May 2007 and our own Presbytery Retreat at Rocky Valley in April 2008.

#### **Low Points for Prayer & Possible Action**

- 1. ASSESSMENTS: Our Presbytery record for payment of assessments remains abysmally poor.
- 2. ATTENDANCE: Although there has been some improvement in attendance of official Presbytery events, this still remains a cause for concern, especially as devotions seem to be treated as an opportunity to arrive a little later rather than the very foundation of all that follows. Furthermore, there appears to be a racial pattern to who attends what, ie black ministers and commissioners at events hosted by urban congregations.
- 3. REPORTS: While the quality of reports has improved significantly, submission is often well past the specified deadline, leaving the Presbytery Clerk and Administrator with an almost impossible task to circulate the documents in time for the Presbytery meetings.
- 4. COMMITTEES: In many cases, our Committees comprise only the Convenor and possibly a Co-Convenor, with the result that
  - 1. very little progress is made
  - 2. we lose the benefit of diverse input
  - 3. there is inadequate training of fresh leadership to carry our Presbytery into the future.
- 5. SEDIBENG: This was a completely new responsibility for our Presbytery this year, as well as an innovative approach to the spiritual and pastoral care of the students living at Sedibeng. Unfortunately, the idea has had to be revisited as it is not working out in the way Presbytery had hoped.
- 6. PASTORAL CONCERNS: During my two-year term as Moderator, two of our ministers passed away ie Revs Mandla Hlongwane and Reuben Kgopong; two of our ministers moved to other Presbyteries, namely Revs Ruth Armstrong and Ewald Moerman; and several of our ministers and their spouses required fairly extensive pastoral care, which was provided to the best of our ability predominantly by Theo

and myself. A representative pastoral team, including Theo, myself, and Elder Commissioner Kevin Nkitseng, had to be constituted to deal confidentially with a particularly sensitive issue. Several meetings were held with various parties over a few months. These are still ongoing.

A confidential report dealing with the meetings held to date has been written and sealed in an envelope in case there should be any need in the future to refer to this matter. At this stage, indications are that false allegations may have been made, but, regardless, the issue is not currently relevant since it dates back some 10 years or more, with no indication that the problem is ongoing. The aim is to attempt to bring about reconciliation if at all possible. This is the point of any further meetings that may be held. If necessary, a further confidential report will be written concerning any subsequent meetings that may held and sealed in the envelope together with the first report for possible future reference if needed.

#### Conclusion

We have very real reason for celebrating in the goodness of God as shown in the many highlights listed above. We also clearly need to revisit our levels of commitment and willingness to fulfil our responsibilities as servants of God in our Presbytery as revealed in the low points listed above.

My sincere thanks to each and every one of you for your love and support over the past two years. A very special thank you to Theo for graciously and quietly guiding, correcting and prompting me from the sidelines when necessary. It's so good to experience the Body of Christ in this way, as fellow Christians complement each other and contribute together to make God's ministry more effective in the world.

I wish Patrick Nyauza and Chris Moore God's blessings as the incoming Presbytery Moderator and Clerk, and pray that they may also be enfolded in your love and care as Theo and I have been.

- 3. Presbytery instructs each congregation to collect a letter from the Finance Committee of General Assembly to help clear up unresolved payments.

### 2.3 Treasurer's (Eddie Stopforth)

- 1. The Income Statement for the period ending 30 September 2008 and the Balance Sheet as at that date are attached. The usual Notes have been appended to both documents. I am also attaching a report on Assessments received to this date and a schedule of Annual Returns received.
- 2. Grants to congregations are being drawn from three sources:
  - 2.1.Mamelodi and Mamelodi Gardens are receiving grants from the GA Maintenance of the Ministry Committee. This money comes into the Presbytery from that Committee and is then paid to the congregations. Delays in receiving these funds from GA result in delays in the money being transferred to the congregations in question.
  - 2.2. The funds being used to maintain ministry at Ruighoek are covered by the Presbytery and consist of travel expenses for the Interim Moderator. No funds are currently being paid to the congregation itself.
  - 2.3.And finally, two congregations (Khayakhulu and St Peter's) are receiving "Pedal Project" grants. These are paid by the Presbytery and the funds recovered by transferring money from the appropriate deposit account.
- 3. You will recall that we agreed that Khayakhulu, as the beneficiary of the 2008 Project,

would receive a total of R80 000, which would be made up of an increased (to R20 000) contribution from the Presbytery and the contributions received from congregations. We also agreed that the Presbytery would make up any shortfall that was experienced.

3.1. This amount was used as follows

R40 950 was paid for the motor vehicle and

R39 050 was paid in cash, making

R80 000 in all.

3.2. The following contributions have been received from congregations:

PLEASE check these figures. It is possible that Project contributions were credited to Assessments.

- 3.3.If we add the Presbytery's contribution to this income we reach a total of R43 000 which more than covers the amount advanced for the building work that was done. The balance of R3 950 (plus what Project income still needs to be accounted for) can then be set off against the purchase price of the vehicle, which, in point of fact, Khayakhulu has the use of although ownership vests in the Presbytery.
- 4. PLEASE check the attached Assessment Report. Apart from my concern that contributions to the Project may have been picked up here, I am particularly concerned about any assessments due to GA which may have been paid into the Presbytery's account, for onward transmission. Please check your records and advise me if I need to transfer any money to GA on your behalf.
- 5. As a final comment: 9 months into the year we have a surplus of R52 000. Clearly God is pouring His blessings out on us. We need to be mindful, as we look into the coming year, that we are called to be good stewards of His resources and to put the money to use for His Kingdom and not for our personal benefit.

- 9. Presbytery allows Eddie Stopforth the opportunity to present some proposals with regard to the Order of Lay Preachers.,
- 10.Presbytery holds a Vacancy Workshop on 21 January 2009 (9h00-13h00) at Jonas Lediga all Interim Moderators to attend.
- 11. Presbytery receives the report on the Project for 2009.
- 12. Presbytery notes the formation of a General Assembly Executive Commission planning committee.

# 3. Church Growth and Missions

### 3.1 Church Growth and Missions

(Theo Groeneveld and Dennis vd Spuy)

Again, it has been a busy time. The conveners met and agreed on the following principles:

- 1. Identifying Growth Areas and starting to strategise around them was a key function of this committee's work. The other key issue was the maintenance and monitoring of our new works.
- 2. Nuclear Congregations should be handled under this section this will form the basis of a Church Development Forum.
- 3. We should continue to have an outward Missions focus promoting, supporting and doing work outside our denomination's usual sphere of influence. This should be promoted with an annual missions conference.

Also the following resolution from General Assembly with regard to the Maintenance of the Ministry (MOTM) should be noted:

The Committee will accordingly adopt the following policy with regard to Grants in aid for 2009:

- The committee will endeavour to have a conversation with every Presbytery
  Committee responsible for Church Growth and Maintenance of the Ministry every
  year to ascertain the needs and plans of the Presbytery with regards Grant receiving
  congregations;
- Then the committee will issue a new comprehensive questionnaire which will request detailed information on congregations in decline, new church development and congregations in economically challenged settings. This questionnaire will include a formal application for funds;
- At its last meeting of the year, the committee will allocate a grant to each Presbytery which applies based on the questionnaire and application listed in item 2 above.
- The committee will partner with the Assembly's committee on Church development and planning for this process and we shall endeavour to work in close collaboration with them so as to avoid unnecessary duplication. We will also consult with the Ministry committee of Assembly regarding appointment of probationers.

It is not entirely clear whether this year's applications for next year fall under the new system, but as we have not been contacted by the committee and have not received the questionnaire, I think it safe to assume that the "old" system applies.

#### 3.1.1. Grace

Services at Grace continue with a steady attendance of 40-60 people. Finances are good and a steering committee has been formed. In all likelihood Grace is going to move from NGK Moreleta to Emmanuel's building for the following reasons:

We have reached a growth ceiling at Grace. The people who are currently attending
Grace have invited everyone they know to come to services. Grace does not have a
full-time minister to slowly grow the congregation as Theo and Brenda were able to
do at Emmanuel. There are challenges with the current venue (addressed below)
which make it very difficult for a first-time visitor to even find the venue where the

Grace Service is being held. The way for additional growth to happen is to become more visible.

- There are some "obstacles to growth and worship" where Grace worships at the moment. When we initially decided to go to the current venue, we had the complex pretty much to ourselves. The parking lot would be empty and the complex would be quiet when people arrived. Now we share the facility with another congregation (an arrangement we agreed to for the sake of the bigger Kingdom-of-God picture) and while relationships are good and the other congregation bend over backwards to accommodate us, there are some practical difficulties: The other congregation is huge and their services are lengthening. The parking lot is full of cars busy leaving as Grace worshippers are arriving. The foyer and outside areas are filled with people having tea as we are trying to start our service. There are often accidental interruptions of our worship service. While our "regulars" are fairly tolerant of these interruptions, it is not conducive to attracting visitors. The venues for Sunday School classes are not ideal. The venue is basically a hall and does not have the warmth of a sanctuary.
- The NGK Moreleta building has been sold to Choose Life Church. This congregation
  is growing rapidly and may decide to start a second service and this would leave us
  without a venue. (Again, let me emphasise that the Choose Life congregation have
  bent over backwards to accommodate us there is no negativity in our relationship
  with them.)

We are pretty convinced that moving from the current venue is inevitable. We need a venue that provides all-week visibility and more of a "church" ambiance.

Now that Grace has its own identity firmly established, Session believes that moving the Grace Service to Emmanuel's building while maintaining its character and timing would be very positive. We would be two like-minded churches sharing one building, but Grace has the clear goal of getting land, calling a minister, and moving on. Emmanuel would be serving as an incubator and, when Grace moves on, the 10h30 time-slot could become the incubator for the next congregation we plant! (SAINTS Presby acted as an incubator for the Centurion Presbiteriaanse Kerk. So this is not without precedent.)

### 5.6 Report on ministry in the greater Rustenburg area.

This is in response to one of the recommendations of the Planning Meeting...

Present: Mrs. Eddie Stopforth; Rev. Patrick Nyauza; Rev. Chris Moore.

Historically the greater Rustenburg area: Rustenburg; Ruighoek and Khayakhulu, have been 'neglected' in terms of ministry.

Our churches in Ruighoek and Khayakhulu for the most serve impoverished areas, and ministry under our current model of ministry, where the congregation is solely responsible for the payment of stipend, travel and other ministry related costs is near impossible for them to make.

Rustenburg is certainly financially viable, but are not in a position as yet to call a senior minister, and it would seem that stated supply would be an appropriate measure at this juncture in the congregation's history.

We have some challenges in this area.

- 1. There seems to be great overlaps in ministry geographically. e.g. Four outstations of Khayakhulu are situated literally on Rustenburg's doorstep.
- 2. St. Peter's Mothlutong and Ruighoek both have outstations in a common geographical area: Lethabong.
- 3. Ultimately this means that much ministry opportunity is situated far from the mother congregation, yet in the backyard of another one of the UPCSA congregations of this Presbytery.
- 4. Financially this area needs great assistance.

In terms of Khayakhulu if we choose to appoint a minister there, then, we will be under normal circumstances committed for a three year period. If we suggest that they are R6 000 short per month (rough estimate) this figure has to be multiplied by 36, which amounts to R216 000 *without* annual increases.

Ruighoek would probably be best served by a Probationer, but the congregation is unable to contribute very much to ministry. The idea of a probationer is appealing because we will receive some support financially from the Ministry Committee. Currently this amount is about R1000 per month

Because of the 'overlap' in ministry areas and to acclimatise congregants to potential change it was decided that a team ministry approach would be best suited to serving the greater Rustenburg Community. Essentially this would mean that minster/probationers/stated supply people would be responsible for a congregation but would regularly (perhaps every six weeks) exchange pulpits.

#### Proposals:

- 1. Presbytery receives the Report.
- 2. Presbytery appoints Mr. Vuyo Mbaru to Khayakhulu for a one year period.
- 3. Presbytery requests the Ministry Committee of General Assembly to place Mr. Garikai Mufanebadza at Ruighoek Presbyterian Church.

- 4. Presbytery appoints Advocate Rean Fourie as Stated Supply to Rustenburg Presbyterian Church. (This is covered more fully in a notice of motion elsewhere)
- 5. Presbytery agrees to fund these ministries in conjunction with grants received from Maintenance of the Ministry Committee and the Ministry Committee of General Assembly.
- 6. Presbytery appoints a Commission to bring more permanent recommendations by no later than March 2009 with regards to ministry in the greater Rustenburg area.
- 7. The Rev. Chris Moore is appointed as supervisor to Garikai Mufanebadza.
- 8. The Rev. Chris Moore is appointed as Interim Moderator to the Rustenburg Presbyterian Church.
- Rean Fourie is granted permission to administer the sacraments in the greater Rustenburg are, should he comply with requirements as laid down by the Ministry Committee of General Assembly.

### 8.5 St James - Micah Nthali

#### INTRODUCTION

St.James is a steady growing, purposeful and vibrant congregation that impacts in the environment she finds herself in. She is comprised of three nuclear congregations namely: Matsulu, Driekoppies and Ka-Nyamazane.

#### 2. SESSION COURT

The Session meets every last Saturday of the month on a rotational basis. Where it is scheduled to take place, Session members are bound to visit identified families for prayers and upliftment just before the meeting could start.

In pursuing the status of the congregation to be that of Stated Supply, the Session met with the Presbytery appointed Assessor, the Rev.TH.Munnings and agreed that the matter be taken to the congregation now that it was thoroughly discussed by the Session. A Congregational meeting comprised of all the three nuclear congregational members was convened where the meeting agreed unanimously to be a Stated Supply.

The Holy Communion is dispersed on a quarterly basis. During the special services such as Umnqophiso in the beginning of the year, Maundy Thursday, Easter during Good Friday and Valedictory service during the end of the year. The minister and elders rotate Sunday after Sunday as guided by the preaching plan.

The sessions of St.James and St.Paul have resolved to establishing a forum which is

called the Lowveld Forum after Presbytery had done away with the Mpumalanga Commission which was formed by congregations of Witbank, Ogies, Middelburg, Nelspruit, Matsulu and Marite. The forum is established on the basis of Christian Fellowship, Evangelism and service, Leadership development etc. This structure is convened bi-monthly on a Sunday on a rotational basis. During the convention pulpit exchange is observed where also we end up celebrating through the Holy Communion.

#### 3.BOARD OF MANAGEMENT

The Board of Management meets every first Saturday of the month on a non-rotational basis. Instead, the Treasurer joins the minister in his rotational schedule and presents the monthly financial statement so that the members are aware of the financial situation in the church. In every meeting some motivational talks on stewardship are made to enable the members to understand why they should give. Before the Board meeting, zonal meetings are convened by Zonal Managers under the leadership of the district Elders solely to teach and encourage for better giving for the sustenance of the work of the church.

#### 4. PRESBYTERIAN WOMEN FELLOWSHIP AND MEN'S FELLOWSHIP GUILD

A joint mini-conference of the UPWF and MCG was held during the 11-12 September 2008, where the members of both St.James and S. Paul congregations gathered together to worship. The mini-conference was a success and we were able not to spend a lot of money. This year, these congregations could not join the Tshwane conference simply because of high financial costs they incur every time they go to Pretoria. Though they could not join the rest of the UPWF conference this year, they however deposited all financial requirements needed from them. The Tshwane's continual postponement of its Conference has seen the Lowveld MCG joining hands with the UPWF during the Conference.

The Mini-Conference however resolved to engage the UPWF Executive to request them to be allowed to continue to hold their mini-conference in the Lowveld as this will help save finances. As it was done, financial requirements will be sent to the Tshwane UPWF Executive as they are affiliated there. It is envisaged that the Lowveld congregations could save on transport costs and be able to do the work of the church in their respective areas.

Your prayers and best wishes for St.James and the Lowveld Forum are always and will always be appreciated. Our working together as joint Sessions of the Lowveld constituting this Forum has already shown some positivity in the work and life of the church in this part of the country.

#### Finances

As mentioned in the previous report, finances are still a problem however a sum of R22 000 was raised in August 2008. Monthly contributions are taking place and will be reflected in treasurer's report which is expected at the end of the year. The debt with

municipality is being serviced now after an arrangement was negotiated with the municipality. Due to the renovations that are taking place in the main station in Atteridgeville, the finance committee has proposed that the aim to raise R80 000 by the end of the year be shelved and the congregation deal with debts and renovations for now.

#### ➤ Building renovation

One of the main thrusts of the Thumedi Makgahlela strategy is the renovation of the church buildings in the main station in Atteridgeville. Considerable progress has been made and efforts were focused mainly on replacing the old floor with tiles, painting the walls and the roof, renovating the entrance hall, repairing the private rooms and erecting signage. This has been made possible by the various associations that took ownership of the projects: UPWF contributed R13 000 towards tiling, MCG contributed R7 000 towards painting and signage and the youth R3 000 towards renovating entrance hall. Donations were also received from individuals.

#### > Assessments and Donations

The amount of fees owed to the Presbytery and General Assembly has been confirmed and payment has been authorised.

#### > Training

Members of our congregation attended a training workshop on eldership that was held in St Columbus and a children's ministry training that was held in St Andrews.


